Furthermore, each parent or guardian does hereby release and agree to indemnify any member, officer, director, employee agent, representative, in their individual and representative capacities, their successors and/or assigns, from all claims and rights of any action for personal injury, property damage or losses of any kind, resulting from the participation in or related to the Wee Eagles Football program, whether it result from the negligence or failure to act by any of the officers, directors, employees, members, or other representatives.

Furthermore, each parent or guardian recognizes that medical insurance is not included, but may be available optionally, if interested please contact a board member.

The Registration Fee covers all league, referees, gym, tournament, or other expenses for the season. Each parent recognizes that they are entrusted with the care and return of the equipment issued and hereby understands that should any piece of equipment be lost, stolen or damaged, or other wise not returned in the same condition issued, except normal wear and tear, that they will be held financially responsible for the foresaid equipment.

Additionally, each parent needs to realize that **Volunteering** is critical to the success of our league and each parent will be required to volunteer in accordance with a volunteer schedule which will be drafted at the beginning of the season. Volunteering is mandatory and is not optional. Should any parent not fulfill this obligation, the parents' child may be subject to suspension from his or her team.
